New to the LCHS Collection! Healing on the Homefront: A WWII-era First Aid Kit by Allyson Earl, Museum Manager

Johnson and Johnson began selling their "First Aid Cases" in 1888, first to railroads and factories, and soon after for use in cars, airplanes, the

home, and even for the U.S. Army.

Enter: The Johnson and Johnson "No. 1 First Aid Cabinet"! First branded in the 1920s and standing at 11" x 16" x 6.5", the cabinet is filled with medical supplies and carefully organized into drawers labeled for quick access.

Bridget Godwin Trosper recently donated this First Aid Cabinet to LCHS. Her mother. Marijo Conlon Godwin, was a volunteer for the local Red Cross during World War II, and used the "Cabinet" to store her nursing supplies. In addition, Godwin donated blood, as indicated by the Blood Donor Certificate. found inside the cabinet. The Red Cross col-



lected 13.4 million pints of blood from 6.6 million volunteers during World War II.

Needless to say, Godwin filled her first aid cabinet with more than just the gauze and bandages listed on its drawers. These additions included:

Camphenol - a general disinfectant suggested in Johnson's First Aid Manual (1903) to be used for all sorts



of situations, including disinfecting the bedding and clothing of the sick, preventing odors and mold in damp areas, and washing garbage barrels to prevent the spread of germs.

Perfect Mustard Plasters – paper leaves with a layer of mustard meant to be soaked in water and applied topically to relieve inflammation, and recommended by Johnson's First Aid Manual as a remedy for croup, vomiting, lead poisoning, and nervousness, among other ailments.

Iodine Solution – intended to be applied to wounds to prevent infec-

Godwin most likely used the Cabinet through the years before and after World War II. It's a great addition to the collection, and we're pleased to have it!
